Assumption of the Risk, Waiver of Liability, and Release of All Claims Relating to Coronavirus/COVID-19 and its subsequent forms and variants. The coronavirus, or COVID-19, is a global pandemic and is spread through person-to-person contact.

Good Shepherd Lutheran Church ("GSLC") cannot guarantee that you and your child/ren will not become exposed to or infected with the coronavirus. Attending GSLC events is voluntary and could increase your chances for becoming infected with the virus. I acknowledge that I or my children and are expected to take precautions for the preservation of their own and others' health and safety.

_____ I acknowledge and agree that I or my children and I may not participate in any GSLC event if, on the date of the scheduled event or in the 14 days preceding the event, have had a positive test for COVID-19 or COVID-19 symptoms (including, but not limited to, as fever (100.4 or higher; respiratory symptoms; cough; persistent nausea; shortness of breath; vomiting; difficulty breathing; diarrhea; and/or any two of the following: chills, repeated shaking with chills, muscle pain, headache, sore throat, new loss of taste or smell, cough, shortness of breath, fever, chills, muscle pain, sore throat, new loss of taste or smell (collectively referred to hereinafter as "COVID-19 Symptoms")).

_____ I acknowledge and agree I or my children and I may not participate in any GSLC event if they or I have knowingly had close contact with or extensive exposure (defined as over one hour) with someone with COVID-19 or COVID-19 Symptoms in the 14 days preceding the event.

_____ I acknowledge and agree that I or my children and I will wear a mask/face covering while at GSLC events where it is required by the facility or by law.

_____ I acknowledge and understand that the risk of becoming exposed to or infected by COVID-19 at GSLC may result from the actions, omissions, or negligence of myself and/or my children, including, but not limited to, GSLC employees, volunteers, and other program participants and their families.

_____ I acknowledge and agree that if I or my children experience COVID-19 Symptoms or are diagnosed with COVID-19 by a doctor or a positive test, and I or my children or I have been present at a GSLC event within 14 days prior to the event, I will notify GSLC by contacting the Rostered Leader, Youth Ministry Coordinator and/or Sunday School Superintendent as soon as I learn of my and/or my children's COVID-19 Symptoms or diagnosis

_____ I acknowledge the contagious nature of COVID-19 voluntarily agree to assume all of the risks and accept sole responsibility for any coronavirus exposure or infection or injury to my children or myself. I understand that Good Shepherd Lutheran Church or any of their staff or volunteers cannot be held liable for any exposure to the virus or any harm that may be caused by exposure to or infection by the virus. By signing below, I agree to release Good Shepherd Lutheran Church and its staff and volunteers from any and all liability for the unintentional exposure or harm due to COVID-19.
